**Please read the following instructions carefully; they should furnish all the information you need to help you follow through on your responsibilities.**

**REPORTING DATE:** Wednesday, March 13, 2019

**REPORTING TIME:** Coaches and players report by 9:00 a.m.

**REPORT TO:** A.E. Wood Coliseum, on the campus of Mississippi College, Clinton, MS  
The Coliseum parking lot is located on Hwy 80 between Springridge Road (I-20 Exit 36) & Clinton/Raymond Road (I-20 Exit 35)

**WHAT TO BRING:** 1. All practice apparel—shorts, socks and shoes. Shorts should be athletic shorts – no cutoffs.  
2. Casual shorts, slacks and shirts.  
3. *Remember to bring the money you've collected for ticket sales (and any unsold tickets when you report).*

**WHAT NOT TO BRING:** M.A.C. rules will not permit male players to wear earrings during any of the All-Star activities. Therefore we advise those of you who wear earrings to leave them at home. Failure to comply with this rule will result in dismissal from the team. Female players cannot wear earrings in practices or the game.

**CONDUCT:** All players will be under the supervision of the All-Star Coaches. You have agreed to follow all the rules of the Mississippi Association of Coaches, and are expected to keep your word.

M.A.C. Board policy states that "should any All-Star Player violate any rule of conduct of the Association, that player will be sent home immediately."
